Dear Parent of a Middle School Student:

As required by the Georgia Department of Education and the Georgia Mandate for Sexual Abuse and Assault Prevention Education, RCPS health teachers will instruct students in the areas of human growth and development, adolescent sex education, disease prevention, and sexual abuse, assault, and exploitation prevention. The above curriculum will be developmentally appropriate for each grade level. The program will assist students in coping with social and peer pressures they face today. It will help students develop skills to say "no" to behaviors in which they do not wish to engage. If your student is receiving this instruction in a virtual environment, RCPS encourages parents/guardians to take appropriate steps to ensure that younger children in the home are sheltered from the lessons because of the sensitive nature of the topics being taught. RCPS also encourages parents/guardians to talk with their students before each lesson in hopes of minimizing disruptions.

The growth and development of young people are important, and it is essential to give careful consideration in providing meaningful experiences for them. In our curriculum, all pertinent concepts are presented in a logical, sequential manner beginning in kindergarten. As of August 2018, the Georgia Mandate for Sexual Abuse and Assault Prevention Education requires students enrolled in grades K-9 to annually receive age-appropriate sexual abuse and assault awareness and prevention education. Kindergartners are taught that creatures of the same kind produce others of the same kind, middle school students are introduced to the correct anatomical terminology while identifying the physical and emotional differences between males and females, and high school students receive training that will prepare them for parenting.

What follows is a summary of the objectives to be addressed in the middle school growth and development unit of the Health Curriculum.

- 1. Through an introduction of correct terminology, students will be able to ask questions and discuss sex education accurately.
- 2. Through group activities, students will be able to identify the physical and emotional changes that occur during adolescence.
- 3. Through discussions and digital videos, students will identify differences between males and females.
- 4. Through discussions and digital videos, students will learn behaviors appropriate for interacting with persons of the opposite sex.
- 5. Students will understand some of the problems related to pre-marital sexual activity and how to effectively avoid them.
- 6. Students will explore how sex is used by the media to sell products.
- 7. Students will study about the transmission of HIV, the effects of AIDS, and cause/effects of STDs.
- 8. Students will learn the positive consequences of choosing abstinence.
